AMENDMENT TO DECLARATION AND GRANT OF EASEMENTS

THIS AMENDMENT TO DECLARATION AND GRANT OF EASEMENTS is made this <u>18th</u> day of February, 2000, by WCI COMMUNITIES, INC., a Delaware corporation formerly known as Florida Design Communities, Inc. ("WCI").

WITNESSETH:

WHEREAS, that certain Declaration and Grant of Easements was recorded on December 13, 1996, in Official Records Book 2772, Page 2889, public records of Lee County, Florida ("Declaration and Grant"); and

WHEREAS, the Declaration and Grant was recorded by Florida Design Communities, Inc. ("FDC") against certain real property owned by FDC lying and situate in Lee County, Florida; and

WHEREAS, FDC is now known as WCI, and accordingly WCI is the Declarant under the Declaration and Grant; and

WHEREAS, Section 6 of the Declaration and Grant provides that the Declarant has the right, in its sole discretion, and from time to time until such times as Declarant no longer owns any portion of the property subject to the Declaration and Grant, to amend the Declaration and Grant for the purpose of revising the legal descriptions for the easements declared and/or granted hereunder, eliminating any easement declared and/or granted hereunder which is later determined to be unnecessary or erroneous, or adding additional easements which will benefit the parties referenced in this instrument; and

WHEREAS, Declarant remains the owner of a portion of the property subject to the Declaration and Grant, and as such desires to amend the Declaration and Grant to modify certain easements as provided hereinafter;

NOW, THEREFORE, in consideration of the foregoing, Declarant, for itself and its successors, assigns and designees, hereby states as follows:

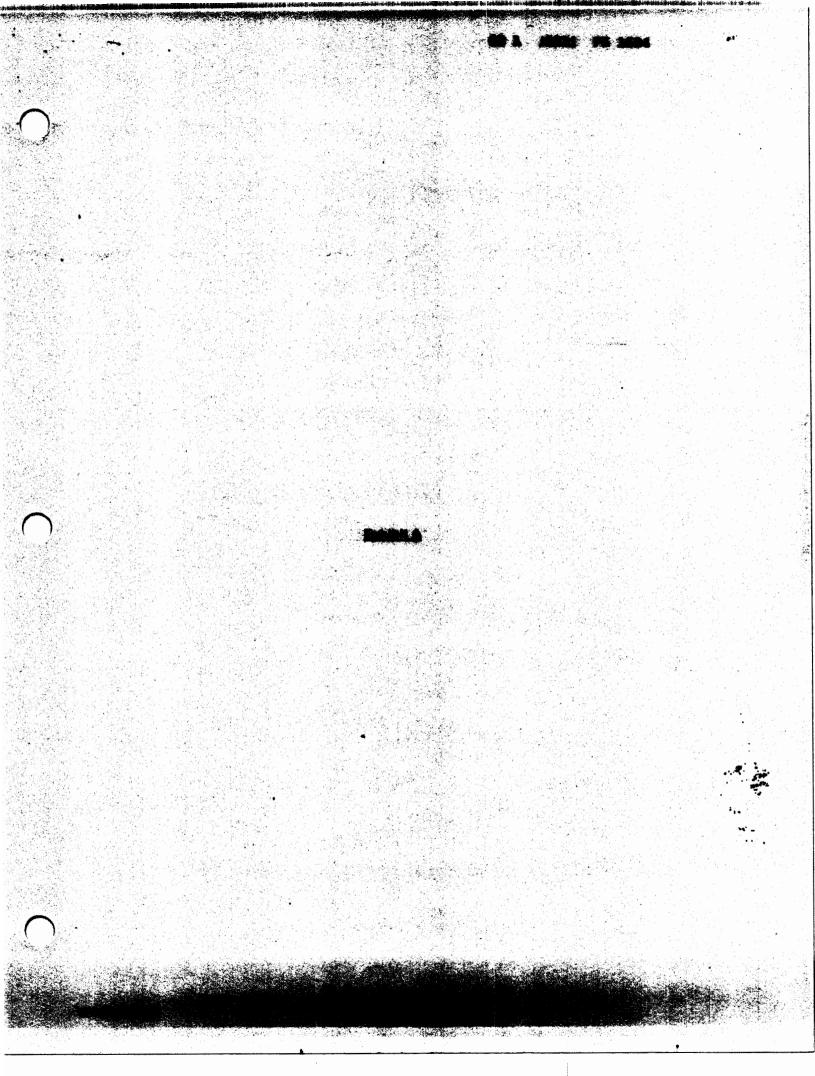
- 1. Recitals. The foregoing recitals are true and correct and are hereby incorporated by reference.
